### **MINUTES**

The meeting was called to order by Chairman Jim Draeger at 6:21 pm.

Jim made a motion to approve the agenda. Randy second. Motion carried.

The minutes from the October 14, 2025 board meeting were reviewed. Jim made a motion to approve the minutes after updating Randy's motions to Jim or John, as Randy was absent from this meeting, and changing Switlick to Seubert Trucking. Randy second. Motion carried.

Public Comment: Thank you to Dennis & Diane Bergs who have donated their time and resources to caring for the Pioneer Tessmer cemetery for the past 30 years. Ditching was done on Lover's Lane, there are some concerns about the steepness of the slope on the north side of the road.

Clerk's Report – The state is hoping to pass a bill that would require Clerk's to offer 20 hours of in person absentee voting time. The County will be adding a \$6 Special Charge per septic system to the tax bills.

Torrie read the Treasurer's Report. Randy made a motion to file the Treasurer's Report. John second. Motion carried.

Supervisor's and Chairman Reports – Rented a pole saw to cut low hanging tree branches over the road. Completed ditching on Lover's Lane. Checked with the insurance company regarding 4-H using the shop area to cook for an event, and they confirmed that is allowed, there is no liability issue. Bridge inspections were completed, the Sandstone Falls Trl bridge needs to have the silt fence removed and the Jersey Falls Trl bridge needs to be swept off, and the cracks need to be sealed. Jim made a motion to correct the bridge issues from the KBIS report. Randy second. Motion carried. Received our PASER Road Ratings back.

Discussion and Adoption of 2026 Town Budget – Randy made a motion to adopt the 2026 Budget. Jim second. Motion carried. Discussion regarding what we could use our excess funds from the 2025 budget for. Suggested a brush cutter. Maybe granite a ½ mile of Schoolhouse Ln.

Randy made a motion to approve and pay the bills. John second. Motion carried.

The mail was reviewed.

John made a motion to adjourn at 7:35 pm. Jim second. Motion carried.
