The meeting was called to order by Chairman Bill Wunsch at 7:00pm.

The Pledge of Allegiance was recited.

John made a motion to approve the agenda with the addition of Item #9A to Review the Increased Costs for the Edgar Fire & Ambulance Contract. Randy second. Motion carried.

The minutes from the January 15, 2025 board meeting were reviewed. Bill made a motion to approve the minutes. Randy second. Motion carried.

Public Comment: Resident requested that the Town of Rib Falls contribute money towards other townships who are needing assistance with their legal fees to fight the wind turbines. Will bring up at the Annual Meeting to get input from the residents. Received a comment on the great job Brian has done with grading and plowing the roads.

Clerk's Report – Insurance Audit was completed. Election Equipment Test went well. Primary election will be held on Tuesday February 18th.

Supervisor's Reports – Call from landowner on Lover's Lane, north ditch is full, water will not drain out. Previously fixed the area to the east of the cross culvert but not to the west. We will look at it in spring. Town Hall drain line froze up, Brian and John thawed it out. Repaired leaking hydraulic pump on red patrol truck.

Public Communication – Discussed request from a resident regarding having a Town of Rib Falls Facebook page. Users would need their own Facebook account to see the page and we could not guarantee reminder notifications would always be seen by the users. There are currently a few Rib Falls community based pages already out there where neighborhood information can be shared. Our town website is more easily accessible to all internet users. Bill made a motion retain the Rib Falls website as our official form of communication for our residents. Randy second. Motion carried.

Review Edgar Fire & Ambulance Contract – The Ambulance Fees were increased to help build the Ambulance Replacement Fund. Randy made a motion to approve the Edgar Fire Protection & Emergency Service Contract for 2025-2026. John second. Motion carried

Review Draft 2024 Annual Financial Report – John made a motion to approve the 2024 Annual Financial Report. Randy second. Motion carried.

Annual Meeting Discussion – April 16, 2025 – Will review PASER ratings to see which roads we plan to work on this year.

Bill made a motion to approve and pay the bills. Randy second. Motion carried.

The mail was reviewed.

Randy made a motion to adjourn at 8:01 pm. John second. Motion carried.
