

# **TOWN OF RIB FALLS REGULAR BOARD MEETING**

## MINUTES

The meeting was called to order by Chairman Jim Draeger at 6:00pm.

The Pledge of Allegiance was recited.

Randy made a motion to approve the agenda. John second. Motion carried.

The minutes from the July 8, 2025 board meeting were reviewed. Randy made a motion to approve the minutes with updating Public Comment to show the State covering the cost of the County Materials road. John second. Motion carried.

Public Comment: The Town bulletin board is in rough shape, suggested updating the materials and cleaning it. Brian did a great job grading the roads with the dryness.

Alysia read the Treasurer's Report. Jim made a motion to file the Treasurer's Report. Randy second. Motion carried.

Clerk's Report – Confirmed with the State of Wisconsin - Division of Alcohol Beverage that licensed bartenders working in our township do not have to provide an updated Responsible Beverage Server Training Course certificate each year, as long as they have continuously maintained their license. Election equipment was dropped off and picked up from the courthouse for software updating and servicing of the machines.

Supervisor's and Chairman Reports – Granite Falls Trl needs 520 square feet of pavement replaced. Quote received from Dodson's for \$3,025. Randy made a motion to accept the bid from Dodson's. John second. Motion carried. Will proceed with replacing a culvert on Pheasant Falls Rd just south of Hwy U at a cost of roughly \$3,800. Lumber Falls Rd culvert is being replaced, it was approved in May, the town is covering the cost of the pipe and granite, Roger Ross is covering the remaining costs. Washout on Grass Creek Ln was fixed last month. Will review road budget and may do ½ mile of granite on Schoolhouse Ln, north from Hwy U, and/or we may do more ditching in fall. Will determine if we have another culvert that could be submitted for culvert aid for next summer. There will be a Wind Turbine Meeting on Oct 1 at the Town of Day town hall.

- a.) Review Quotes Received for Building Painting – After looking over the building exterior, it was determined that the south side needs more than just painting, the metal needs to be repaired or replaced and it may need insulation in several areas. The estimated cost is over \$5,000 so a bid request needs to be published in the paper.
- b.) Discuss New Town Sign – Will keep looking into options.
- c.) Continued Conversation Regarding Dust Control – Possible tax increase to put dust control throughout entire township, will address this at the next annual meeting.

The mail was reviewed.

Randy made a motion to adjourn at 7:29 pm. James second. Motion carried.
