MINUTES

The meeting was called to order by Chairman Jim Draeger at 6:00 pm.

The Pledge of Allegiance was recited.

Jim made a motion to approve the agenda. John second. Motion carried.

The minutes from the May 12, 2026 board meeting were reviewed. John made a motion to approve the minutes. Jim second. Motion carried.

Public Comment: A resident is wondering when the County is going to do brushing on Hwy 107 from Hwy U to Hwy 29. We will contact them and see if they have a plan for it.

Alysia read the Treasurer's Report. Jim made a motion to file the Treasurer's Report. John second. Motion carried.

Clerk's Report – The ADA Report from the last election was received, there are four items to correct: 1) The Van Accessible parking sign on the outside of the building needs to be raised higher, 2) The town hall door opening tension needs to be adjusted to 8.5 pound, 3) A sign labeling the accessible voting equipment needs to be next to the voting machine and 4) The tactile keypad and headphones need to be plugged into the accessible voting machine. The annual fee for our website domain renewed for \$15. Need to file Maintenance of Effort report for the Fire Departments.

Chairman & Supervisor's Reports – Door handle & lock replacements completed. Started working on granite: 1 mile on Lover's Lane, ½ mile on Pheasant Falls from Lover's Lane to Cherry Grove, ½ mile on Boulder Falls Trl, ½ mile on Countryside Dr west of Hwy S. Will do remaining ½ mile on Countryside Dr next. Replaced culvert on Lover's Lane last week. Will be replacing a few culverts: a 36" cross culvert on Silver Falls Trl near corner of Hwy H, one on Nugget Falls Trl and one on Pheasant Falls Rd, north of Hwy U. New letters for the Town of Rib Falls wording were ordered. Two electricians came to look at the shop lighting, one more electrician will get us an estimate for the next meeting.

Review and Act on Building Painting Bid – Jim made a motion to accept the Chuck Mengel bid for \$4,250 to paint three sides of the building to match the south side of the building. John second. Motion carried.

Review and Act on Weiks' Pub & Grill Liquor License and Operator's Licenses - Jim made a motion to approve the Liquor License for Weiks' Pub & Grill and the Operator's Licenses for Colleen Handrick, Robert Weiks Jr, Tracy Seehafer, Maureen Anklam, & Adrienne Dallman. John second. Motion carried.

Jim made a motion to approve and pay the bills. John second. Motion carried.

The mail was reviewed.

John made a motion to adjourn at 7:22 pm. Jim second. Motion carried.
