Clerk's Report – Started working on Form CT. Received a \$61 refund from Insurance Audit. Election will be held on April 7th. Equipment Testing will be done on March 30th.

Review Draft 2025 Annual Report – Will add a few notes to the last page about garbage can placement and send to printer.

Supervisor's Reports – Checked into signing a new Diesel Fuel Contract but they aren't offering contracts at this time. Lots of washouts from rain last Saturday. Seubert Trucking hauled granite for us to fill in the washed out areas. A culvert on Highland Dr is collapsing and the road has a hole, Brian will look at it tomorrow. Will work on crowning the roads that have water standing on them. The Marathon County Register of Deeds said the Town does not own any of the land for the Tessmer Cemetery, two Tessmer families own it. We plan to purchase security cameras for the Town Buildings. Replaced oil seal on Red Plow Truck. Grader blades are ready to be picked up at the County shop. Still reviewing Small Culvert Grant to see if we have any culverts that would be eligible.
