

# **TOWN OF RIB FALLS REGULAR BOARD MEETING**

## MINUTES

Those present: Jim Draeger, Randy Ross, John Hummer, Alysia Seliger, Torrie Socha, Brian Witberler, Judy Hummer, Susan Schmidt

The meeting was called to order by Chairman Jim Draeger at 6:00 pm.

The Pledge of Allegiance was recited.

Randy made a motion to approve the agenda. John second. Motion carried.

The minutes from the November 11, 2025 board meeting were reviewed. Randy made a motion to approve the minutes. Jim second. Motion carried.

Public Comment: Brian has done a great job plowing. Mail will not be postmarked until it reaches the sorting facility so tax payments will need to be mailed sooner to be considered on time.

Torrie read the Treasurer's Report. Randy made a motion to file the Treasurer's Report. John second. Motion carried.

Clerk's Report – Tax information was submitted.

Appoint 2026-2027 Election Inspectors - Randy made a motion to approve the Election Worker List for 2026-2027. Jim second. Motion carried.

Supervisors and Chairman Reports – Issued a burning permit. Started looking into options for town sign ideas to present at the Annual Meeting. Siding replacement on the south side of the building was completed. Will look into options for painting remaining three sides.

- a) Discussion on Ditch Mowing – Our brush cutter reaches 12 feet. We would like the brush cutter to reach 20-24 feet but that size won't work on our tractor. We could rent a tractor and mower together for around \$112/hr or have J&J cut it for us for \$85/hr.

Review and Act on Town Workers Pay - Randy made a motion to increase the Full Time Town Employee Wages by 50 cents an hour and add an additional \$50 per month to his retirement benefit, to increase the Part Time Town Employee Wages by \$2 an hour, and to increase the Janitor's Wages for Mowing Lawn to \$15 per hr, effective 1-1-26. Jim second. Motion carried.

Review and Act on Transferring Funds to Allocation Accounts – Jim made a motion to transfer the following amounts. John second. Motion carried.

- \$110,000 to Equipment Replacement for a new total of \$250,000
- \$25,000 to new account for Ditching/Brushing
- \$15,000 to Exterior Town Hall Siding Painting
- \$15,000 to new account for Culvert Replacements

Randy made a motion to approve and pay the bills. John second. Motion carried.

The mail was reviewed.

John made a motion to adjourn at 7:40 pm. Jim second. Motion carried.
