John made a motion to approve the agenda. Randy second. Motion carried.

Public Comment: A resident commented that Bobcat Falls Trl turned out nicely. Some recycling pickups on Pheasant Falls Rd were missed last week. Question on why the Town maintains the road into County Materials. The State covered the cost of the construction of the road and the town is responsible for maintaining it.

Torrie read the Treasurer's Report. Randy made a motion to file the Treasurer's Report. John second. Motion carried.

Clerk's Report – Filed Maintenance of Effort reports for the Fire Departments.

Review & Act on Weiks' Pub & Grill Liquor License and Operator's Licenses – Randy made a motion to approve the Liquor License for Weiks' Pub & Grill and the Operator's Licenses for Colleen Handrick, Robert Weiks Jr, Tracy Seehafer, Jen Borchardt, Maureen Anklam, Alexa Borter, & Adrienne Dallman, pending receipt of their current completed Alcohol Seller/Server Course Certificates. Jim second. Motion carried.

Chairman and Supervisor's Reports and Road Review – Tessmer/Pioneer Cemetery on Hwy H Mowing – Patricia Tessmer who has a relative in the cemetery, put an ad in the local newspapers asking for a volunteer to mow the cemetery regularly. Bobcat Falls Trl mud hole was dug out. Granite was put on Raven Falls Trl. Town Hall has been stuffy and humid. Brian will check to see if the old dehumidifier still works. Jim made a motion to purchase a new dehumidifier if needed. Randy second. Motion carried.

- a) Discuss & Vote on Repairing Blacktop on Granite Falls Trl at Hwy 29 Intersection A 10'6" by 23' spot needs repair. If there is leftover material, there is a 3' by 10' area on the corner that could also use repair. We would likely need to extend the patch around the corner for it to hold up. No decisions made at this time, will vote after we have received quotes.
- b) Hwy 29 Repair from Hwy H to Purple Martin Ln Project will replace the existing Hwy 29 eastbound pavement and asphalt shoulders, from 2,100 feet west of County H and 2,000 feet west of Purple Martin Lane. Scheduled for 2030, but may start in 2027 if funds become available. Hwy 29 Repair from Hwy 97 to Pheasant Falls Rd Project will replace the existing Hwy 29 westbound pavement and asphalt shoulders from 0.5 mile west of Hwy 97 and approximately 0.5 mile east of Pheasant Falls Road. The

- project will replace the existing pavement at the County H interchange with WIS 29, as well as the westbound entrance and exit ramps. Scheduled for 2026.
- c) Discuss Exit Ramps on Hwy H Periodic ramp closures will occur during this work.
- d) Options for Painting Town Hall Will obtain a few quotes to review at our next meeting.
- e) Options for New Town Hall Sign Will look over ideas to present at our next meeting.
